

DSC Rifle

The rifle garage, shed, and firing line sea container to remain closed to shooters with access by RSO only as needed. Outdoor Ranges will be open to Members 18 and older Only. Members include Associate Members.

All Covid-19 prevention best practices will be adhered to that are in effect the day the range is used. All Range Officers are to wear masks and gloves along with the use of hand sanitizer as outlined below.

Rifle

The Rifle Range opening date will be determined by the BOD.

These ranges will open for DSC Members 18 and older Only. Members include Associate Members. Functions are to include: Sporting Rifle, Service Rifle, Senior Smallbore, Silhouette, Black Powder, Open Shooting, Member Shooting, and LE Rentals. These rules do not apply to LE Rental shooters.

Non shooting spectators are not allowed during this phase.

Do not visit the range if you have a fever, cough, or shortness of breath.

Activities with people outside your household will include some risk of COVID-19. Do not visit the range if you are at a Higher Risk for Severe Illness from COVID-19.

Do not visit the range if you have tested positive for COVID-19 unless you have later tested negative.

Do not visit the range if you have had direct contact in the past week with someone known to have symptoms consistent with COVID-19.

Do not visit the range for 2 weeks after any air travel.

Do not visit the range if you are sensitive to bleach.

All are to wear masks when others are within 6'. RSO's will use gloves or hand sanitizer often for their own protection when signing shooters in, setting up, or cleaning up. If you wear gloves, you should use hand sanitizer on them often and

dispose after that range session. Don't put the gloves in your coat or bag at the end of the day.

Range fees **MUST** be paid with exact change; cash or check. If currency is used, RO's should use hand sanitizer on their gloves immediately after handling currency. No pop or water will be sold to shooters.

All shooters need to wear masks when approaching the range and interfacing with the Range Safety Officers. Masks may be removed to shoot when in position. Masks may be removed when downrange if a 6' distance is maintained. Shooters of the same household are not immediately known to all, therefore everyone will be treated as if they are from different households.

The rifle garage, shed, and firing line sea container to remain closed to shooters with access by RSO only as needed. (except port-a-potty)

Port-A-Potty will have high touch areas sprayed with disinfectant at the start and end of the shift an hourly.

Sandbags to be placed in zip lock bags to allow use of disinfectant spray after each shooter. Shooters are recommended to bring their own sandbags.

Benches and blocks will be sprayed with disinfectant after each shooter. Shooters are recommended to bring their own blocks.

One spotting scope will be available for RSO use only. Shooters needing a spotting scope shall bring their own.

Target frames will be provided to shooters to install and retrieve. The RSO will spray the target frame with disinfectant after each shooter is done.

DCS BOD will provide PPE equipment, hand sanitizer and spray/wipes for RSO use. Shooters to provide their own PPE equipment and hand sanitizer.

The rifle range will be limited to use of odd numbered lanes and the 'lane 21' sight in box. This will put shooters nominally 12' on center. Shooting positions will be identified to meet best practices for Covid-19 prevention.

Each shooter will be assigned a bench. People waiting to shoot will be requested to do so at their vehicle in the parking lot. No congregating on the cement areas while waiting to shoot. Masks must be worn when signing in.

No grouping of people anywhere on the range or parking lot.

No food or beverages except what is brought in by the shooters for their personal needs and consumption. The range coffee pot is not to be used.

Waiver forms will not be available because non-member guests are not allowed to shoot during this first phase.

Only the RSO or designate will use the golf cart. The cart will be sprayed with disinfectant at the end of the shift.

Shooters are strongly encouraged to bring their own staplers. RSO will spray disinfectant on staplers after each shooter use.

Position shooters MUST bring their own mats and spotting scopes.

Pens, timer, etc. will be wiped with disinfectant at the end of the shift.

Tall shooting benches will remain in the garage and not be used during this phase.

Returnable cans are to be discarded or taken home by the person that brought them during this phase.

Disinfectant to be 1/3 cup bleach to 1 gallon of water as recommended by the CDC (<https://www.cdc.gov/coronavirus/2019-ncov/prevent-getting-sick/disinfecting-your-home.html>) or a commercially available product. Disinfectant to be made available in a spray bottle.

It will be up to the committee to maintain sanitation around the range using the best practices for Covid-19 control in effect at that time.

Covid-19 posters are already posted on all DSC Buildings and Ranges and will be updated as they are available from the CDC.

The Range Officer has complete authority on rules violations! First violation is a warning and the second violation constitutes removal from the range.

All such violations will be documented on an incident report filed with the DSC Office. The DSC BOD will act on all such incidents.

Your presence on the range indicates acceptance of these policies and procedures.

Safety is everyone's responsibility, and now that includes infectious diseases.

Signage:

- 1) SHOOTING BY MEMBERS ONLY AT THI TIME
 - a. Posted on the sign off Juengel road
 - b. Posted on each side of the garage overhead door
 - c. Posted by the sign in bench
- 2) MASKS REQUIRED BEYOND THIS POINT
 - a. Posted on each side of the garage overhead door
 - b. Posted by the sign in bench

PPE & sanitary needs:

- 1) Disposable masks
- 2) Disinfectant spray
- 3) Disinfectant wipes
- 4) Hand Sanitizer
