

## **Skeet & Trap Covid-19 Prevention Best Practices**

### **Skeet and Trap Opening TBD**

**All Covid-19 prevention best practices will be adhered to that are in effect the day the range is used. All Range Officers are to wear masks and gloves along with the use of hand sanitizer.**

- 1. The Skeet and Trap DSC Members and Guests.** A Member who brings a guest is responsible for their guest and must ensure that they also follow the rules.
2. Enter Range Building using only the South entrance and you will only be allowed just far enough in to reach the Pro Shop window. **You must call the Pro-Shop (586-739-3502) for admittance.** Only 1 person is allowed in the building at a time. It is preferred the one member per squad enters and pays for the squad. **Masks are required for building entrance.** Other squad mates should wait in their vehicles. Maximum of 1 person waiting on the porch for admittance. All transactions will occur through the Pro Shop window. There will be no entry into the Pro Shop and no further entry to any other part of the building. Barricades will prevent movement beyond the Pro Shop Window.
- 3. One person pays for the entire squad at the pro shop using the touch less credit card reader, by check or cash.** They then receive the controller and card. Let the Range Manager know the number of rounds you and your squad wish to shoot. If you are a single shooter you will be asked to join up with a squad with an opening. We will not be loaning any equipment, pouches, glasses or ear muffs. If cash was used the Manager should sanitize their gloves immediately after handling the money.
4. Once you have paid and received your controller and card, **you and your squad should drive to the assigned field.** Assemble your equipment by the nearest gate and enter the range at that point. If shooting multiple rounds, they must be shot back-to-back with minimal breaks in between.
5. Masks on the field are optional but **Social Distancing “MUST STRICTLY” be observed!** All squad members must be 6 feet apart. Each squad will be given sanitizer products to use on the controller and surfaces.

**6. We will be sanitizing exposed surfaces including the clays controllers, control boxes, and door handles on a regular basis throughout the day.**

7. We ask that you bring your own gloves, disinfectant, and whatever else you deem necessary to protect yourself and squad mates. **You are participating in an outdoor activity at your own risk due to the COVID-19 pandemic.**

8. The first violation of any of the rules is a warning from the Range Officer, **any subsequent violation you and your entire squad will be required to leave the premises without reimbursement**

9. Upon completion of your rounds, the member will **again call the Pro Shop (586-739-3502) and return controller along with range card** for cleaning and disinfecting.

**10. Absolutely “NO” gathering inside the Range Building, on any of the porches or outside seating areas.** The inside restrooms are not available for use. Port-A-Potties will be available and are sanitized regularly.

11. The Pro-Shop is open for supplies with curbside pick-up only.

**12. The Range Officer has complete authority on rules violations!** First violation is a warning and the second violation constitutes removal from the range. All such violations will be documented on an incident report filed with the DSC Office. The DSC BOD will act on all such incidents.
