Voting Timetable

Additionally, the DSC Office will be open Saturday, Nov. 21, from 10 a.m. to 2 p.m. Polls close Dec. 2, 2020 at 8 p.m., prior to the DSC General Membership meeting. You must be in the office to cast your vote prior to 8 p.m. If you would like, you may vote by absentee ballot (see Absentee Ballot Procedures). A sample ballot, with the slate of candidates, is printed on page 14 and posted on the DSC website.

The Rifle committee held its meeting Oct. 8. It was held in person at the DSC Clubhouse and concurrently on-line. About 14 committee members attended.

The item that generated the most discussion is one that is quite familiar to the committee members. It started as a discussion of range rates but soon branched off into range officer staffing for open shooting. Every week we struggle to staff the range. Every year, the pool of range officers shrinks. Today, it is but a puddle. The direct problem is that there are barely enough range officers to keep the range running. There seems to be enough ROs on paper, but once you subtract out the range officers for police rentals and

leagues and take out those that have aged out, etc. the number is small.

The rather complicated process to become a range officer contributes to the problem. The first step is to take the NRA RSO class. This costs money and is only offered a twice a year. Then, the trainees must arrange to work on the range three times and get three signoffs. Eventually, they get their NRA card and take this card to the office and get a DSC RSO card. Then they take that DSC card and completed training forms to the rifle chairman. He signs another form and the applicant can take that form to the office to apply for a range key if they would like. I estimate that it takes 6 months or more from

the initial thought "I'd like to be a RO", until they get a key.

While having enough ROs is the direct problem, the real problem is that there are simply not enough members. If you do not have a large pool of members, where are you going to find ROs. So, how do we interest the younger shooters we see every weekend on the range to become members? I don't know the answer to this but wish I did. But until we can attract members that are younger than retirement age, we will continue to find it hard to staff the range for open shooting and eventually for leagues as well. Any suggestions?

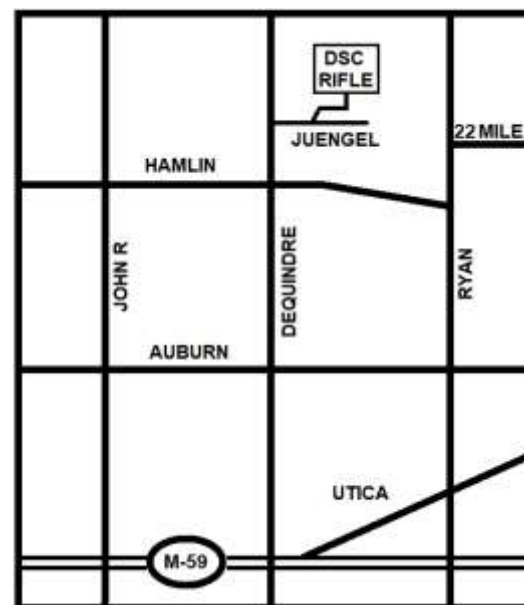

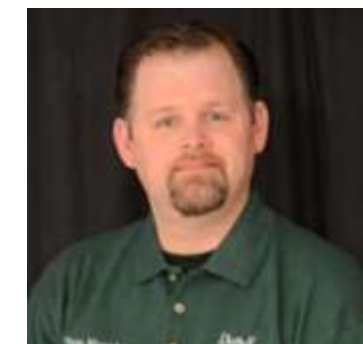
Information about yourself and club involvement you would like included in your resume included in the Plaid & Khaki.
