DSC Associate Member for League Competition at DSC

Effective June 1, 2026

Fee Structure: The DSC Associate Member will be charged \$10 per month of the League duration for both Indoor and Outdoor Leagues (example, a 4 Month League = \$40).

Outdoor Range League

The League shooting fee will equal the average cost of the DSC Member Open Shooting Fee and the Non-Member Open Shooting Fee, (example DSC Member \$10 + Non-Member \$22 = \$32/2= \$16 for each League Day fee for an DSC Associate League Member shooting outdoors. *Associate membership is for the leagues only. It only entitles you to **participate in the leagues and use of the clubhouse**. It does not include any other member benefit. Associate members are non-members and pay guest fees at all DSC venues, including open shooting on all DSC ranges.*

- ***Active-Duty Military and Law Enforcement (with current I.D.) shoot at DSC Member Rate***

Indoor Range League

The League shooting fee will equal the average cost of the DSC Member Open Shooting Fee and the Non-Member Open Shooting Fee, (example DSC Member \$12 + Non-Member \$24 = \$36/2= \$18 for each League Day fee for an DSC Associate League Member shooting indoors. *Associate membership is for the leagues only. It only entitles you to **participate in the leagues and use of the clubhouse**. It does not include any other member benefit. Associate members are non-members and pay guest fees at all DSC venues, including open shooting on all DSC ranges.*

- ***Active-Duty Military and Law Enforcement (with current I.D.) shoot at DSC Member Rate***

For Both Indoor and Outdoor Leagues

All Banquet Fees must be paid by the League participants and included in all published League Fees.

Any deviation from the above fee structure must be approved by the DSC Board of Directors 60 days in advance of the Leagues starting date.
